Please read these Terms and Conditions (hereinafter "**Terms**" or "**T&C**") carefully before using Our Tools (data or services provided via Our website https://twitterwatcher.com or through Our API, application programming interface, in the form of graphs, charts, alerts, raw data or provided in any other form – hereinafter "**Tools**" or "**Twitterwatcher**").

"Black Swan Hunter", "We", "Our" and "Us" refer to Black Swan Hunter Sp. z o. o., a company incorporated pursuant to the laws of Poland under court registration number (KRS) 0000858589 and having its registered office at Sygneczów 112, 32-020 Wieliczka, Poland. Your access to and use of the Tools is conditioned on your acceptance of and compliance with these Terms. These Terms apply to all visitors, users and others who access or use the Tools or Our website https://twitterwatcher.com (hereinafter "You" or "User").

Tools for Registered Users
